

#### State Payments to Two Companies for COVID-19 Testing

#### What is a "special review?"

- Not a financial audit or program evaluation
- We may undertake special reviews in response to complaints/allegations or legislative requests
- In this case, we provided an expedited response to concerns expressed to us during the 2021 legislative session



#### Conclusion

 Based on our review of the early months of the state's COVID-19 testing contract with two companies, there is no evidence that the state or its contracted insurers made excessive payments to the companies



## MDH entered into an emergency contract for testing in late 2020

- Saliva specimens
- Two companies: Vault for specimen collection and Infinity BiologiX (IBX) for specimen analysis
- Contract specified maximum price per test—from insurers first and (potentially) then from the State of Minnesota
- Test recipients not responsible for costs
- Contract expires no later than September 2021, with MDH payments not to exceed \$75 million



## We focused on payments made through publicly funded programs

- DHS-administered health care programs
- MMB-administered State Employee Group Insurance Program (SEGIP)



### DHS-contracted health plans paid a fraction of billed amounts

- We examined claims through March 2021
- Health plans paid:
  - 25 percent of Vault's billed amounts
  - 33 percent of IBX's billed amounts
- Companies submitted no claims during this period on behalf of DHS fee-for-service clients



# MMB-contracted health plans were also paying well below the billed amounts

- One health plan had paid 35 percent of Vault's billed amounts and 32 percent of IBX's billed amounts
- The other two MMB-contracted health plans had not yet authorized any payments as of April 2021; they were negotiating individual contracts with the companies



### Health plans said the companies submitted excessive bills

- They said claims did not accurately reflect the services provided in many cases
- But they did not attribute this to ill intent by the companies, suggesting there was a learning curve for COVID-19 billing



## **Companies said they used standard billing practices**

- Vault and IBX said they have charged the same amounts to all insurers
- They said some insurers pay at or near the standard billing rates, but many pay substantially less



# MDH has paid a small amount so far under the Vault-IBX contract

- Maximum state obligation under the contract: \$75 million
- Most expenses paid so far were for initial set-up costs
- Only about \$3 million paid so far for payments for direct testing costs





- For clients in managed care, state-contracted health plans have helped to ensure that the state does not overpay for COVID tests
- For clients in state-paid fee-for-service care, there were been no Vault and IBX claims submitted as of the time of our analysis





- The number of claims processed at the time of our analysis was limited, so state and health plan officials should review future claims carefully
- We did not examine claims submitted by Vault and IBX to insurers on behalf of privately insured people, and we do not know how carefully those insurers scrutinized these bills
